SANTA BARBARA COUNTY HEALTH DEPARTMENT USE OF WAKE CAMPUS FACILITIES

During the winter break, SBCC Administration collaborated with the Santa Barbara County Department of Public Health and the Santa Barbara County Office of Emergency Management to offer vaccinations at the Wake Campus.

Vaccinations began occurring at the Wake Campus on January 5, and are expected to continue for the next few months. Vaccinations are being administered per the prioritization guidance from the State and County. SBCC has been honored to aid in the distribution of vaccines to community members by providing space at the Wake Campus to the County.

VACCINATIONS FOR EDUCATION SECTOR

In early January, the District received confirmation from the Santa Barbara County Public Health Department that current SBCC employees will be eligible to receive the COVID-19 Vaccine in Phase 1B, Tier 1 as part of the "Education" category. Vaccinations are a rapidly evolving health challenge. Our Public Health Department is working diligently to secure enough vaccines to provide to our entire community. The District is awaiting further information on when it will be SBCC's employees "turn" to receive vaccinations.
